

# NJ Gurukul Terms & Conditions (NJG T&C)

Page 1

## 1] DEFINITIONS

- "Agreement" means and includes the NJG T&C (terms and conditions), the NJ Gurukul Member Registration Form and the Training Enrolment Form and the Candidate's unconditional acceptance of the same
- "NJ" shall mean NJ IndiaInvest Private Limited, it successors, executors, administrators and permitted assigns
- "NJ Gurukul Member Registration Form" or "NJ GRF" means the form as specified and issued by NJ Indialnvest or as downloadable from NJ's website
- "NJ Gurukul Member" or "Member" shall mean such person as identified in the NJGRF accompanying this NJG T&C and as defined herewith
- "Training Enrolment Form" or "TEF" means the specific forms as published by NJ, either physical or online or in any other format, from time to time, for different Trainings as described in that particular form
- "Receipt" or "TEF Receipt" is an acknowledgement of the TEF duly being filled and submitted to NJ by the candidate for enrolment to the concerned training services or modules
- "Training" or "Training Services" or "Modules" means the specified training or development programs, including but not limited to the contents, training materials, etc thereof, as set out in the TEF and conveyed to the concerned candidate
- "The Trainer" means the person as identified in the "NJ GRF" and selected for the purpose of delivering or conducting or presiding over specified Trainings
- "Fees" means and include the charges for the Training as defined in these NJG T&C and/or the TEF or brochure or such other material or communication of the concerned Training as may be revised from time to time
- "The Candidate" or "the Trainee" means the person intending to be a prospective candidate for any training as indicated in the TEF duly registered for that
  particular Training and as defined in this NJG T&C. The candidate would generally mean the member of NJ Gurukul or a candidate duly registered by member,
  subject to the TEF.
- "Clause" means a clause under these terms and conditions and as mentioned / specified in the TEF
- "The Date(s)" for the Training means the date(s) upon which the Training and/or Training Services will be held and the timings thereof as communicated to the candidate(s) from time to time or as mentioned in the TEF, and/or due receipt thereof
- "Websites" shall mean www.njgurukul.com or such other websites, including but not limited to online user accounts or desks, web pages, URLs of NJ where matters & contents related to NJ or NJ Gurukul or the trainings are showcased
- "NJ PSC(s)" or "NJ Partner Service Centre(s)" means such premise(s) comprising the NJ centre or branch from where the activities of NJ are carried out, including but not limited to Training
- "Personal Data" means the data as furnished by a living individual to NJ who can be identified from such data or information
- "The Training Location" means the place at which the Training Services are to be held/ organized by NJ as set out in the TEF and/or due receipt thereof

### 2] Training Services

- 2.1 NJ is in the business of advisory & distribution of various financial products and services to various Clients. To provide a holistic platform and support to both existing and prospective clients/advisors, NJ offers many services under various names & styles
- 2.2 NJ offers services related to training and development under the name & style of "NJ Gurukul" to train, and/or develop various people, including but not limited to advisors, distributors & employees of NJ or of people associated, directly or indirectly with Partners / Advisors of NJ, or such other identified person(s) or any person(s). The members of NJ Gurukul would get access to the various trainings as conducted by NJ from time to time

the person, as identified in NJ GRF, has approached NJ for the purpose of registration as a NJ Gurukul member And on furnishing relevant information, duly signing this NJG T&C and on the acceptance thereof by NJ, the said person would get enrolled under "NJ Gurukul" as member thereof. Such member will be eligible to apply for and attend the various trainings for which he is eligible, on payment of the fees as mentioned or revised in TEF from time to time.

- 2.3 NJ shall arrange the various Training(s) on the scheduled Date(s) for particular training to be hel
- 2.4 The training shall comprise of such training services as specified in the TEF or in any other communication and shall be held using different aids, and techniques as deemed fit, in sole discretion of NJ

#### 3] Fees, Refund of Fees

- 3.1 The Fees charged by NJ for the trainings covers the cost of training materials and books, if any, supplied by NJ, use of appropriate facilities, Trainer's time and any room or equipment rentals that NJ undertakes and all such other incidental and related expenses incurred directly or indirectly to the Training made by NJ
- 3.2 The relevant examination fees and other specific expenses / charges will be charged to members and / or candidates separately or shall be included with the Training fees, and will be specifically mentioned in the TEF.
- 3.3 All the other charges, including but not limited to, any traveling, stationery, communication, lodging, boarding, foodings and refreshments or any other incidental or consequential expenses incurred by candidates related, directly or indirectly, to such training, unless otherwise specifically stated or provisioned as per TEF, would be borne in full by the candidate(s) themselves and in any circumstances NJ shall not be liable, in part or in full, to reimburse or bear the same
- 3.4 Under no circumstances will NJ be liable to 'refund', either in cash, in kind or otherwise, in part or in full, any fees or any other amount(s) paid in relation to, directly or indirectly, for any training by the member and / or candidate, for any reason whatsoever. Even if the member or candidate has failed to attend the training on such date(s) the candidate will have no recourse either for re-training or for the refund of fees, in part or in full.

#### 4] Transfers, Cancellations and Postponement

- 4.1 Only eligible persons, as defined in the TEF or any such communication can be registered as candidates for the concerned Trainings (Only Members or his representatives/nominees)
- 4.2 Only registered candidate shall be allowed to attend the training and the candidate may be asked to prove his/her identity before or any time during or after the training. In case of failure to comply with, the candidate shall be liable to be expelled or denied to attend the training. NJ holds all the discretionary rights to judge upon the identity of the candidate and take the necessary actions. Such action shall be final and conclusive. NJ would not reimburse, refund or make good any fees or amount(s) paid or borne by the candidate in relation to such training.
- 4.3 The candidate cannot transfer / substitute his candidature / seat for any other person, unless otherwise specifically stated in the TEF. Any other person who wishes to undergo the training, he/she, mandatory need to be a registered member of NJ Gurukul first, unless otherwise as stated in TEF, and then has to enroll for the specific trainings for which he is eligible by paying the fees as set out in the TEF.
- 4.4 The candidate cannot forfeit, or cancel his candidature for training once the TEF has been signed & submitted and the payment made. In case the candidate does so for any reason whatsoever, he or she would not have any recourse of any kind.
- 4.5 In case the candidate wishes to change his or her training from one date to any other date, the candidate or the member must make the request in writing, or otherwise as specified in the TEF, at least 7 clear working days prior to the date of commencement of such training to the concerned person or place as identified and set out in the TEF. The onus of ensuring and confirming the acknowledgement / receipt of the said communication rests solely on the candidate or member.
- 4.6 In case, no request for change of the training date is received by NJ, within period specified in clause 4.5, and / or there is delay in receipt of the same, the member or the candidate would be treated as if he or she is attending the training on such Training Dates and will have no recourse if he or she is unable to attend the same for any reason whatsoever.
- 4.7 No refund request of the fees once paid either in part or full would be entertained in any circumstance.

#### 5] Members and Candidates

- 5.1 The candidates shall act reasonably well throughout the training. Candidates are required to maintain proper discipline and etiquettes during, before and after the training session at the training venues
- 5.2 In the interest of the other candidates / smooth completion of the training program, NJ may expel/remove/disqualify candidate(s) from a training session in case the candidate's behaviour is not as expected or if the candidate interferes during the training session and obstructs the smooth functioning of the same.
- 5.3 The opinion/decision of the Trainer in this regards shall be final and the candidate will not have any recourse, including but not limited to the refund of such training fees paid and other consequential or incidental expenses incurred, directly or indirectly to such training, upon such expulsion / removal / disqualification, non-availability of the training
- 5.4 NJ does not claim or guarantee that the candidate undergoing the training would successfully clear or pass any such certification or test for which such specific training was undertaken. The extent of benefit from any training program purely depends upon the candidate's own abilities, efforts, understanding, focus and memory.
- 5.5 In case, the member nominates any candidate, other than himself / herself as per the TEF for any training, the concerned member shall continue to be responsible for all acts & omissions of such nominated candidate. By signing these terms & conditions, the member understands and agrees to bear all the obligations and full responsibility for such candidates and be liable to bear any actions, claims, damages, losses, suits, proceedings, demands, or expenses, costs, charges, for any act of the candidate further to breach of any of these terms & conditions.

#### 6] NJ's Right and Obligations

- 6.1 NJ represents that it has taken due care and caution in providing information on its Training and Websites and that the information / references may be taken from external sources. - 7.2 NJ owns all the websites, intellectual property whether of a technical, commercial or any other nature, presented or displayed, on websites or forming a part of any, directly or indirectly, of any training or training kit or such materials as distributed with regards to the trainings and / or as membership of NJ Gurukul.
- 7.3 The Candidates shall not, during the training period, or at any time after its completion, divulge any such information to any person not authorised by NJ, in writing, to receive it and shall not utilise any secret or confidential knowledge or information or any intellectual property acquired, directly or indirectly, in connection with or as part of the training to the detriment or prejudice of the other party or use the same for any purposes save for the purposes of this terms & conditions. - 7.6 NJ states that it will only use the Personal Data of the member and candidates for the purpose of carrying out its obligations hereunder and ensures that all reasonable and appropriate measures are in place to protect the Personal Data. NJ may use the data to communicate the members and the candidates of the new products, services, offers or trainings as launched or available and deemed fit by NJ.
- 8 **Indemnification:** The Candidate expressly agrees to indemnify and hold harmless NJ, its subsidiaries, affiliates, officers and other partners, and its and their respective employees, from and against any and all damages, liabilities, actions, causes of action, suits, claims, demands, losses, costs, and expenses arising directly or indirectly from or in connection with the members and / or the candidate's acts or omissions further to these TEF terms and conditions.
- 9 This Agreement sets out the entire agreement between the parties in relation to the subject matter hereof and supersedes all previous arrangements, agreements and representations whether written, oral or implied between the Candidate and NJ relating to the Training Services
